Property overview

This split entry is like no other and has increased the square footage with its recent renovation. The park like yard and 4 season porch allows for a relaxing environment. The home is located in a quiet well established neighborhood with shopping and restaurants within a 5 minute drive. Close to the new Target Headquarters with the Mississippi River close by. 20 minute drive to downtown Minneapolis with easy access to Highways 169 & 610.

Covered entry leads to a rustic Tuscan brick foyer adding warmth and depth. Spacious well planned kitchen that was updated in 2006 has pergo flooring with a large center island and snack bar. There is ample cabinetry and recessed lighting. The dining area is illuminated by a chandelier and leads to the 4 season porch via glass paned French doors. The large 4 season knotty pine porch gives the home an “Up North” feel. Three bedrooms are on the upper level with custom closet organizers and are serviced by a

full bath. A sliding patio door leads to an expansive deck which is a great spot for summer entertaining. A private tree lined back yard has a fire pit for those cooler evenings.

The lower level has a Master bedroom with organizers in the double closets. There is a large family room and new ¾ ceramic bath with heated ceramic flooring, enlarged pentagon shower and large vanity. There is a large laundry and storage area with a chute from the upper level.
